General Terms and Conditions

- 1) **Acceptance of agreement:** This agreement and general terms must be read, signed and returned to the Knight PALS Secretary to be considered a Knight PALS member and obtain Knight PALS membership benefits.
- 2) **Privacy Statement:** We are committed to protecting your privacy. Authorized officers within the organization, on a need to know basis, only use any information collected from individual members. We constantly review our systems and data to ensure the best possible service to our club members.
- 3) **Mission and Goals:** The mission of Knight PALS for Autism is to promote autism awareness and initiate inclusive programs for adults (18+) with autism spectrum disorder who are students at UCF and/or are registered with UCF-CARD. Knight PALS members understand that the club's primary goals are to promote autism, provide inclusive programs for adults with autism, and enhance the lives of individuals with autism through our programs.
- 4) **Club Dues:** Knight PALS members are required to pay a membership fee of \$20.00 each academic year. All active members, including officers, are required to pay membership dues. Membership fees will be collected by the Treasurer during fall and spring semesters only. Full or partial refunds can only be granted upon a 2/3 affirmative vote of the officers.
- 5) **Meetings and events:** Officers are required to provide at least but are not limited to two social events per semester, two club meetings per semester, and one workshop, per semester. Members are required to attend at least one club meeting per semester.
- 6) **Members covenant noninterference:** Members shall not attempt to direct Knight PALS officers on duty, exclude them from the club, demand work from them, or interfere in any way with the Knight PALS officers' duties.
- 7) **Communication and limitation on liability:** Knight PALS officers are voluntary UCF students— not paraprofessionals. They are not required nor qualified to treat, diagnose, work, and/or meet one on one with club members. Knight PALS officers are just responsible for organizing Knight PALS' social events, workshops, and trainings. Therefore, Knight PALS officers will not share any personal information (cell numbers, Facebook, etc) with any club members. If a member needs to contact a specific officer they will do so through the club's main email address knightpals@live.com If an officer needs to contact a member privately they will do so through the club's main email address. Notifications will be sent through emails and/or be posted onto our website and Facebook.
- 8) **Publications and Advertising:** All graphics and publicity of the organization must comply with UCF's Golden Rule (<http://goldenrule.sdes.ucf.edu/>), Event Policies, Student Union and other building guidelines, and the UCF University Marketing Graphic Standards (<http://umark.ucf.edu/logo/>). No Knight PALS officer and/or member will use the club's networks (Facebook, website, newsletters, etc.) to publish profanity and/or corrupting notifications. The secretary and president must unanimously approve all graphics and publicity prior to duplication and distribution. The secretary and president also have the right to delete and/or get rid of any publications they feel go against these terms.
- 9) **Revocation of Membership:** Membership may be revoked without mutual agreement for non-participation, misconduct, or violations of any provisions of the constitution. The member will be notified in writing of the possible revocation at least 72 hours prior to the vote and will be allowed to address the organization in order to relate to members any relevant defense prior to the voting for removal. Membership can only be revoked upon a 2/3 affirmative vote of active student members.
- 10) **Reinstatement of Membership:** Membership may be reinstated after one full semester has passed. The former member may submit a request for reinstatement to the President. At the next membership meeting, the organization must vote on the reinstatement request. Membership may be reinstated by a 2/3 affirmative vote of the active student members.
- 11) **Effective date of this agreement:** This agreement becomes effective when signed, dated and returned to the Knight PALS secretary.
- 12) **Notification of changes:** Our club reserves the right to change these conditions from time to time as it sees fit and your continued membership will signify your acceptance of any adjustment to these terms. If there are any changes to our privacy policy, we will announce that these changes have been made on our home page (and on other key pages on our site), through email, and at our club meetings. If there are any changes in how we use our club members' Personally Identifiable Information, notification by e-mail or postal mail will be made to those affected by this change. Any changes to our privacy policy will be posted on our web site and announced at our meetings 30 days prior to these changes taking place. You are therefore advised to re-read this statement on a regular basis.
